Program on local government issues presented to Leadership Hazleton

The Local Government Issues Committee of Leadership Hazleton, Class of 2003-2004, presented the November program during a full-day session at Hazleton City Hall.

The goal of the day was to explore several programs throughout the area that foster discussion with law enforcement and local officials pertaining to regionalization.

The day began with class members hearing from Bob Skulsky, who spoke about C.O.G. (Council of Government). Skulsky is executive director of Mountain Council of Governments and the Greater Hazleton Civic Partnership.

Joe Yannuzzi then followed with further information on COG. Yannuzzi is chief financial officer for Crossroads Computers Inc. Yannuzzi was the originator of the Mountain Council of Governments and is the president of COG. He also is a Hazleton city councilman.

The group then heard from Jim Philips, representing the Pocono Mountain Regional Police Force, who spoke about the pros and cons of regionalizing.

The group then broke for lunch, which was sponsored by Leader Data Processing and General Mills and provided by Genetti's.

The afternoon session began with a tour of City Hall, including a tour of the police station by Officer John Leonard, Hazleton Police Department. Leonard has been with the Hazleton City Police Department for over eight years and is assigned to the patrol division as the shift officer in charge.

He is also a member of the local SWAT team and the Crime Prevention Unit. The group also saw a K-9 demonstration, which was presented by Officer Greg Rossi and his partner, Bart. Rossi has been with the Hazleton Police Department for seven years and the K-9 unit for 5½ years. Bart is a 6½-year-old black German Shepherd who is a cross dog, which means he is both a patrol and a narcotics dog.

The planning committee for this program was comprised of Lena Kotansky facilitator, Economic Development Officer, City of Hazleton, Sheila Kay Albertson, Robert Benjamin, C. Jeffery Mason and Robert Tracy.
